No.15/7/2025-DMU/Rect: ~~1207~~ **WHEREAS**, the University issued notification vide notification no.3/1/2028-DMU/Rect/2020-II dated 19<sup>th</sup> December, 2020 for recruitment of 88 Assistant Professors for 22 different departments.

**AND WHEREAS**, during the recruitment process of the 88 Assistant Professors, the University has increased 60 additional posts of Assistant Professor vide letter no.UHE-1001/3/2022-HTE-DHTE dated 12.07.2024.

**AND WHEREAS**, these 60 additional posts were distributed amongst 22 subjects as per the requirement of the departments. Department of Physics and Botany have got 9 (nine) and 7 (seven) additional posts respectively in addition to the earlier 4 posts each.

**AND WHEREAS**, the result of the selection committee(s) for 20(twenty) subjects/departments were declared vide notification no.3/1/2028-DMU/Rect/2020-I(Pt) dated 18.07.2024 except Physics and Botany (due to technical issues) subsequent to it some candidates have filed court cases against the recruitment.

**AND WHEREAS**, as per the Hon'ble High Court of Manipur interim order dated 29.07.2024 later modified on 22.08.2025 *"...the D.M. University is at liberty to conduct the proposed interview for seven additional seats of Botany and Nine additional seats in Physics for the post of Assistant Professor in the D.M. University."* *"...However, there shall be no appointment to the four seats of Botany and Physics each which are under litigation."*

**AND WHEREAS**, the same order of the Hon'ble High Court of Manipur was communicated to the University's Legal Advisor for further advice, and the Legal Advisor has submitted his comments/advice.

**AND WHEREAS**, the legal opinion along with the Hon'ble High Court's order was forwarded to the Commissioner, Higher & Technical Education, Government of Manipur, seeking approval vide letter no.15/5/2025-DMU/LEG/Fac dated 22.10.2025 and approval was accorded vide letter no.UHE-1001/3/2022-HTE-DHTE dated 23.12.2025

**AND WHEREAS**, the order of the Hon'ble High Court, advice of the legal advisor, approval of the Commissioner Higher & Technical Education, Government of Manipur were placed before the Syndicate meeting held on 19.02.2026.

**AND WHEREAS**, *"After thorough examination of the relevant documents and in compliance with the order of the Hon'ble High Court granting liberty to the University to conduct the pending interview, the Syndicate approved the conduct of interviews for recruitment to the post of Assistant Professor against 7 (seven) additional posts in Botany and 9 (nine) additional posts in Physics, from amongst the earlier shortlisted candidates in the line of the legal advice received and approval of the Secretariat: Higher and Technical Education, Government of Manipur."*

**NOW THEREFORE**, the University will conduct a fresh interview for recruitment of the additional posts of Physics and Botany from the earlier shortlisted candidates by complying reservation policy as under:

**Physics (9) = 5(UR), 3(ST), 1(OBC-M); Botany (7) = 3(UR), 2(ST), 2(OBC-M)**
